Terms and Conditions 2025

Please read carefully

- 1. All Exhibitors must provide valid Public Liability Insurance for a minimum of £5 million at the time of booking.
- 2. All Exhibitors shall be responsible for their stand and exhibits before, during and after the event. The Exhibitors shall indemnify the organisers against all claims, damages, or expenses whatsoever which may arise through exhibiting at the event.
- 3. Candles or other naked flames must not be lit or displayed within the marquee or halls at any time, due to the risk of fire.
- 4. The Dorset Brocante will not be responsible for the injury, disease, death, or loss caused to any Exhibitor or customer during the event.
- 5. All temporary display structures, shelves, rails, ladders, exhibits and free-standing stock, are to be safely erected and displayed at all times.
- 6. No fire escapes or gangways are to be blocked at any time in the halls or marquees. If you are asked to move your displays, if they are deemed to be blocking a fire escape, you must do so immediately.
- 7. The Exhibitors will be solely responsible for the safe erection of their gazebo on site, including the use of tent pegs or weights to ensure the gazebo is securely attached to the ground in case of windy weather. The Dorset Brocante will not be liable for this.
- 8. The Dorset Brocante will not be responsible for any accidents, fatal or otherwise, that may arise from an Exhibitor taking a stand at the event. It is a condition of taking part, that each Exhibitor shall hold the Organisers' blameless and indemnify them against any legal proceedings arising from such accident/s.
- 9. The Dorset Brocante will not be responsible for the safe keeping of any article exhibited and will require Exhibitors to take charge of their own property.
- 10. Bookings cannot be accepted by phone or email; bookings will only be accepted on the official booking form, with payment by online BACS or credit card accompanied by appropriate insurance cover.

- 11. Cancellations by Stallholders. **If you decide to pull out of an event or cancel your stall booking, there will be no refunds.**
- 12. The Dorset Brocante will endeavour to ensure the fair goes ahead as advertised. However, we cannot be held responsible for events, which are outside our control, such as adverse weather conditions, or events which lead to a change in, or cancellation of the fair. In the unlikely event of the fair being cancelled, or the venue being unavailable owing to circumstances beyond our control (e.g. Coronavirus), we are unable to refund booking fees but will carry over your booking to a future event.
- 13. All rubbish from your stand must be taken away at the end of the event and removed from site.
- 14. All Exhibitors shall remain on site at their stand until the end of the event. Stalls should not be packed away until the fair has closed.
- 15. The Dorset Brocante team and their helpers will not tolerate unpleasant or abusive language or behaviour. Exhibitors who are found to be in breach of this will not be invited to take part again.
